- **4. Update on Groundwater Rules & Regulations:** Wingert reported that he continues to make notes of proposed changes with hopes of having updates for review in the spring. No action.
- 5. Action to Rescind/Amend Motion on Nitrogen Reduction Act Program Guidelines: Hauschild explained that there may not be enough applications to use all the money available. A limit of 280 acres is already set by the state guidelines. He suggested that once all applications are received, the board could determine whether any additional restrictions would be needed.

Schaardt moved, seconded by Sugden, to rescind the following motion from the November 14, 2024, meeting: Moss moved, seconded by Stukenholtz, to approve the Nitrogen Reduction Incentive Act Program guidelines with a maximum per applicant of either \$2,000 or 160 acres. Motion carried.

- 6. A Request for a Variance to Transfer Groundwater by Laurie Saathoff: Wingert explained that there is a conflict within the current rules regarding transfers. The NRD's legal counsel advised waiting to consider this request until the rule conflicts are resolved. No action.
- 7. A Request by Ronald Rowe to Change Irrigation Method: Wingert explained that the landowner had requested to change from gravity flood to center pivot, which would reduce his overall water use even though the number of acres irrigated would increase slightly.

Schaardt moved, seconded by Boellstorff, to approve the request from Ronald Rowe to change from gravity flood to center pivot irrigation. Motion carried.
